Format: All Matches: 2 out of 3 to 25, no cap, 2 TO
Deciding set will be 15 points, no cap, 2 TO

Seedings: Day 1 - determined by Region as best as possible using this season's results
Day 2 - determined by placement within individual pools after results of pool play

Procedures for Breaking Ties:

Two- way ties: Two (2) teams tied in match record

> The first place team will be the team that won the pool play match between the 2 tied teams (head-to-head).

Three-way Ties: Three (3) teams tied in match record

1. Set percentage: The total number of sets played in the pool (sets won divided by total sets played).

2. Point percentage: Each team's total points scored divided by the total points scored by the team's opponents in that pool.

3. Coin toss

Warmups: 3 minutes full court (Serving Team); 3 minutes full court (Receiving Team)

Note: time may be shortened if agreed upon by both coaches or as deemed necessary by Tournament Director.

Time between sets is two minutes.

Protests: No protests will be allowed on judgement calls
All protests will be settled at the time they are filed.
Protests can ONLY be related to the rules of play.

Officials: Aloha Region to provide first referees.
Assigned teams to provide R2 (Adults) ; SC; ASC; LJ; LJ

Awards: Gold - 1st & 2nd, Silver - 1st & 2nd
